

# **Children's National: CASD CHAT**

### Introduction

This issue of CASD CHAT shares two community intervention announcements: the newly available <u>Water Safety Program</u> developed by Parents of Autistic Children of Northern Virginia (POAC-NoVa), and an *Unstuck and On Target!* 15-week program now enrolling for groups beginning in January, 2016 at <u>Behavioral Directions</u>, <u>LLC</u> in Herndon, VA. ### **Water Safety Program**

Thanks to an Autism Speaks Family Community Grant, Parents Of Autistic Children of Northern Virginia (POAC-NoVA) developed a Water Safety Program to guide lifeguards in teaching individuals with ASD how to swim. The Water Safety Program reflects a team effort. It was developed by Lesley Bates, the curriculum author, who was a lifeguard herself and is an educator of children with ASD as well as an ABA home therapist. She has taught numerous children on the spectrum how to swim and instructed other lifeguards in how to teach swimming to children with autism. Meredyth Biggs, a special education teacher and Board Certified Behavior Analyst, reviewed the curriculum, and Kevin A. McGrail, a POAC-NoVA founder who has served multiple roles for the organization, managed the project.

This program was designed by a former lifeguard for any lifeguard to implement. Parents who are interested can take the following steps:



- Print the program materials and discuss it with your local pool manager and lifequard/swim instructor.
- Urge each lifeguard to commit to teaching at least one kid with autism to swim each year!
- Ask your Pool to support & advertise the program. Posters are available to hang!
- Other parents then see the advertisement and ask about it for their children.

• Lifeguard works with the child teaching an important life skill!

The Unstuck and On Target!© Program combines weekly small therapeutic groups with parent training opportunities to create effective change in real life. \*Group size will be limited and we expect to fully enroll the group.
